

Informative according to the article 13 of the law by decree 196/2003

The Society DMC s.r.l. with registered office in PALERMO, via Francesco Petrarca, 5, in the person of the Administrator Pietro Libro, here domiciled, gives you the following informations:

The personal data of the user, given at the moment of his registration at the web site and the admissions to the several services and promotions will be also used by Stratos DMC through communication to third persons in the respect of the protection of the privacy, as per law by decree 196/2003 and the rules in force.

The data will be used by Stratos DMC as follows:

a) in order to provide the requested services, verify the quality of the services and provide all the accounting, legal and fiscal fulfillments.

b) only after received an explicit, proper consent, for commercial, promotional and marketing purposes as well as in order to develop market surveys and statistic elaborations or rather to send technical or promotional informations about several products and services offered by Piaggio and/or dealers and/or distributors of the Piaggio Group. The data could be communicated to societies of the Piaggio group and/or specialized societies (of course these societies will adopt the principles of the data protection as per law in force) for the same purposes as they were collected.

The consent to the use of the personal data for the purposes at the point a) is facultative but necessary to accede to the services, promotions and offers advertised by Stratos DMC and without this information Stratos DMC will not be able to provide the requested services.

The consent to the use of the personal data for the purposes of point b) is facultative and its absence will not block to accede to the services or to the offered promotions.

The personal data will be treated granting the full respect of the contracts, regulations as per law in force. The use of the data will be on line as per the indicated purposes granting the safety and the confidential nature as per the article 31 of the law by decree 196/2004 and the Technical Regulation - annex B. The personal data will be kept just for the necessary period to the above mentioned purposes and therefore for the period prescribed by the civil and fiscal laws.

The data will be used by the holder and also by delegated persons working inside or outside the office. It is possible that some cooperators of other societies involved to supply the services offered by Stratos DMC could learn about these data.

The art. 7 of the law by decree 196/2003 gives some specific rights to the interested parties, in particular they have the right to know about the existence of their personal data, even if not yet entered and that those data will be used clearly. The interested party can also ask to know the origin, the logic and the purpose of the data uses, the references of the data holder, of the person in charge, of the representative on the state territory and of the categories/persons that may knowledge the data in the office of representative on the state territory, of person in charge or delegated person. He can also ask the cancellation, the transformation by an anonymous manner or the block of the data used against the law or the updating, the correction and the integration of the data and the confirmation that the data were given to others.
